### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (P) No. 44/2013/SJD dated 23<sup>rd</sup> May, 2013 and published as S. R. O. No. 428/2013 in the Kerala Gazette Extraordinary No. 1458 dated 27<sup>th</sup> May, 2013, the Government of Kerala constituted the Kerala State Commission for Protection of Child Rights. Clause (a) and Clause (b) of sub-section (2) of section 17 of the Commissions for Protection of Child Rights Act, 2005 (Central Act 4 of 2006)



provide that the State Commission shall consist of a Chairperson who is a person of eminence and has done outstanding work for promoting the welfare of children; and six Members other than the Chairperson, out of whom at least two shall be women, selected from among persons of eminence, ability and integrity from the fields specified in the said section.

The term of two Members appointed vide notification issued under G. O. (P) No. 12/2022/WCDD dated 22<sup>nd</sup> August, 2022 and published vide S. R. O. No. 830/2022 in the Kerala Gazette Extraordinary No. 2805 dated 23<sup>rd</sup> August, 2022 in the Commission expired on 24<sup>th</sup> August, 2025. Government have decided to appoint Sri. Shajesh Bhasker P., Krishna, Poolathodiyil House, UP Hill, Malappuram P. O. - 676505; and Smt. Jalajamol T. C., Saravaram, Muhamma P. O., Alappuzha – 688525 to the said Commission after complying with the provisions in the said Act and the Kerala State Commission for Protection of Child Rights Rules, 2012 by amending the notification issued under G. O. (P) No. 3/2024/WCDD dated 4<sup>th</sup> March, 2024 and published as S. R. O. No. 242/2024 in the Kerala Gazette Extraordinary No. 834 dated 5<sup>th</sup> March, 2024. The term of office and conditions of service of the Members of the Commission shall be as stipulated under section 19 of the said Act and Rule 5 of the said Rules.

The notification is intended to achieve the above object.
