N.Sunanda, Sreethilakom, T.C 12/2467, Kumarapuram, Medical College P.O., Thiruvananthapuram and Smt.Jalajamol T.C., Sarovaram, Muhamma P.O.,



Alappuzha as Members of the Kerala State Commission for Protection of Child Rights, re-constituted vide Notification issued under G.O.(P) No.14/2020/SJD dated 10th August, 2020 and published as S.R.O. No.491/2020 in the Kerala Gazette Extraordinary No.1795 dated 10th August, 2020 and consequently make the following amendment to the said notification, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Clause (b) of sub-section (2) of section 17 of the Commissions for Protection of Child Rights Act, 2005 (Central Act 4 of 2006), the State Commission shall consists of six Members other than the Chairperson out of which at least two shall be women from among persons of eminence, ability and integrity from the fields specified in the said section. As per G.O.(P) No.6/2017/SJD dated 29th April, 2017 and published as S.R.O. No.218/2017 in the Kerala Gazette Extraordinary No.877 dated 29th April, 2017, Government have appointed six members to the Commission after complying with the provisions in the said Act and the Kerala



State Commission for Protection of Child Rights Rules, 2012 made thereunder. As per the G.O.(P) No.4/2019/SJD dated 3rd April, 2019 and published as S.R.O. No.268/2019 in the Kerala Gazette Extraordinary No.900 dated 3rd April, 2019, the Government have appointed two members viz. Fr.Philip Parakatt P.V., Don Bosco, Monvila, Kulathoor. P.O., Thiruvananthapuram and Sri. K.Nazeer, Amnesty, Chaliyam.P.O., Kozhikode in the places of Sri.T.B.Suresh, Thakidiyil House,Valavayal. P.O., Wayanad and Smt.Syamaladevi.P.P., Advocate, Athira, Vidyanagar P.O., Kasaragod respectively whose appointment were cancelled in compliance with the judgment of Hon'ble High Court of Kerala in WP(C) No.1994/2017 and made consequential amendment to the Notification issued under G.O.(P) No.6/2017/SJD dated 29th April, 2017 and published as S.R.O. No.218/2017 in the Kerala Gazette Extraordinary No.877 dated 29th April, 2017. As the term of 4 Members in the said Commission expired on 1st May, 2020, the Government have re-constituted the Kerala State Commission for Protection of Child Rights vide G.O.(P) No.14/2020/SJD dated 10th August, 2020 and published as S.R.O. No.491/2020 in the Kerala Gazette Extraordinary No.1795 dated 10th August, 2020. Since the term of the two members appointed vide S.R.O. No.268/2019 expired on 04.04.2022, Government have decided to appoint Smt.N.Sunanda, Sreethilakom, T.C 12/2467, Kumarapuram, Medical College P.O., Thiruvananthapuram and Smt.Jalajamol T.C., Sarovaram, Muhamma P.O., Alappuzha to the said Commission after complying with the provisions in the said Act and the Kerala State Commission for Protection of Child Rights Rules, 2012 by amending the notification issued under G.O.(P) No.14/2020/SJD dated 10th August, 2020 and published as S.R.O. No.491/2020 in the Kerala Gazette Extraordinary No.1795 dated 10th August, 2020. The term of office and conditions of service of the Members of the Commission shall be as stipulated under section 19 of the said Act and Rule 5 of the said Rules.

The notification is intended to achieve the above objective.
